The following steps need to be followed to make tax payments:

1. Log-on to the Website:





10. Once the transaction is complete, the user need to go immediately click on 'View", and Print the 'Taxpayers Counterfoil'.



There are 2 important points to be noted while doing the same:

1. The E-net Platform will be available from 8am to 9.30pm to make payments.
2. The acknowledgement cannot be regenerated, thus the user must ensure that it is either printed or saved for future reference.
